## ELIGIBILITY

Members of Below Poverty Level (BPL) families as enumerated and photographed in BPL Ration Card and available in the Civil Supplies Department database.

## BENEFITS

- Aarogyasri scheme provides a cashless health benefit cover upto 5 Lakhs per family for 938 tertiary and secondary care medical and surgical therapies, and 125 follow-up therapies.
- 1672 packages covered under the scheme
- 87.5 lakhs families covered under the scheme on a end to end cashless basis.

# RASHTRIYA AROGYA NIDHI (RAN)

## ABOUT

The Scheme provides for financial assistance to patients, living below poverty line and who is suffering from major life threatening diseases, to receive medical treatment at any of the super specialty Government hospitals / institutes.

## BENEFITS

- The financial assistance to a Cancer Patient up to Rs. 2,00,000/- (Rs. Two lakh only) [Rs. 5,00,000/- in emergency cases], would be processed by the RCC concerned, on whose disposal the Revolving Fund has been placed.
- Individual cases, which require assistance of more than Rs. 2.00 lakh, are to be sent to the Ministry for processing. Revolving Funds have been created in all the 27 Regional Cancer Centres (RCCs) and funds upto Rs. 50 lakhs will be placed at their disposal. The Revolving Funds will be replenished on fulfilment of conditions regarding submission of utilisation certificate and list of beneficiaries.

# HEALTH MINISTER'S DISCRETIONARY GRANT (HMDG)

## ELIGIBILITY

Financial assistance is provided under HMDG to the poor patients with family income less than Rs.1,00,000/- annually and suffering from major illness and undergoing treatment in Government Hospitals/ Institutions, to defray a part of the expenditure on hospitalisation/treatment, in cases where free medical facilities are not available.

## BENEFITS

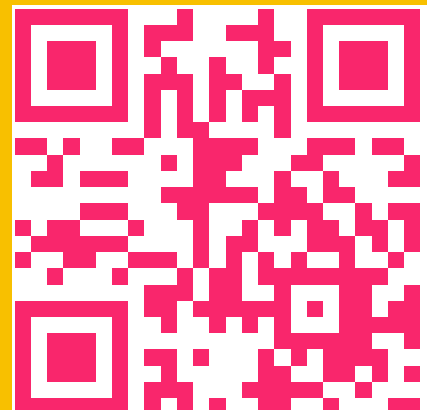
- Rs. 75, 000/- if the estimated cost of treatment is up to Rs. 1.25 Lac
- Rs. 1 Lac if the estimated cost of treatment is above Rs. 1.25 Lac- & up to Rs. 1.75 Lac
- Rs.1.25 Lac if the estimated cost of treatment is above Rs.1.75 Lac

# PRIME MINISTER'S RELIEF FUND (PMRF)

## ABOUT

Prime Minister's relief fund (PMRF) for reimbursement of cancer treatment expenses.

Provides financial assistance to indigent patients for treatment of major diseases at Government/PMNRF empanelled hospitals to partially defray the expenses.

Disbursements are made with the approval of the Prime Minister.

Applicants can apply for grant of financial assistance through an application form addressed to the Prime Minister.

## DOCUMENTS

1. Two passport size photographs of patient (one pasted on application, another stapled with application)
2. Copy of residence proof
3. Original medical certificate incorporating the type of disease and estimated cost of expenditure
4. Copy of his/her income certificate.

# AMBEDKAR MEDICAL AID SCHEME

## ABOUT

The scheme is meant to provide medical treatment facility to the patients suffering from serious ailments requiring surgery of Kidney, Heart, Liver, Cancer and Brain or any other life threatening diseases.

## ELIGIBILITY

- The applicant shall belong to Scheduled Caste and Scheduled Tribe Community.
- Annual family income shall not exceed Rs. 3,00,000/- per annum.

## BENEFITS

- 100% of the estimated cost of the surgery will be directly released to the concerned Hospital with a maximum ceiling limit in the form of crossed cheque/DD.
- Cancer Surgery /Chemotherapy /Radiotherapy = 1.75 Lakhs

# CANCER PATIENTS CONCESSION

## TRAVEL BY RAILWAYS

### ELIGIBILITY

Only for those persons who are Resident of India and suffering from Cancer and are travelling for the purpose of medical check-up/treatment.

### BENEFITS

- 100% concession in AC 3 tier/sleeper
- 75% concession on second class, AC Chair Car
- 50% concession in AC 2 tier and AC first class.
- These are allowed on the basic fares of mail and express trains.

### DOCUMENTS

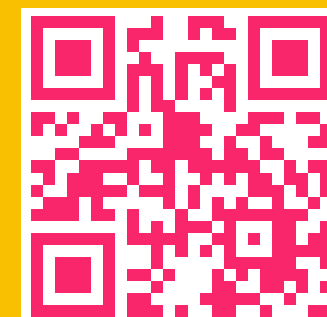
- Concessional tickets are issued on production of a certificate from the head of a cancer hospital or institute where the patient is being treated.
- Outward journey concessions are issued from the station where the patient boards to the hospital where they are being treated. The return journey concessions are issued from the treatment/checkup/discharge centre to the patient's place of residence.
